The corporation is formed as a public benefit corporation under section 501(c)(3) of the United States Internal Revenue Service Code.



Gunderson Foundation Membership

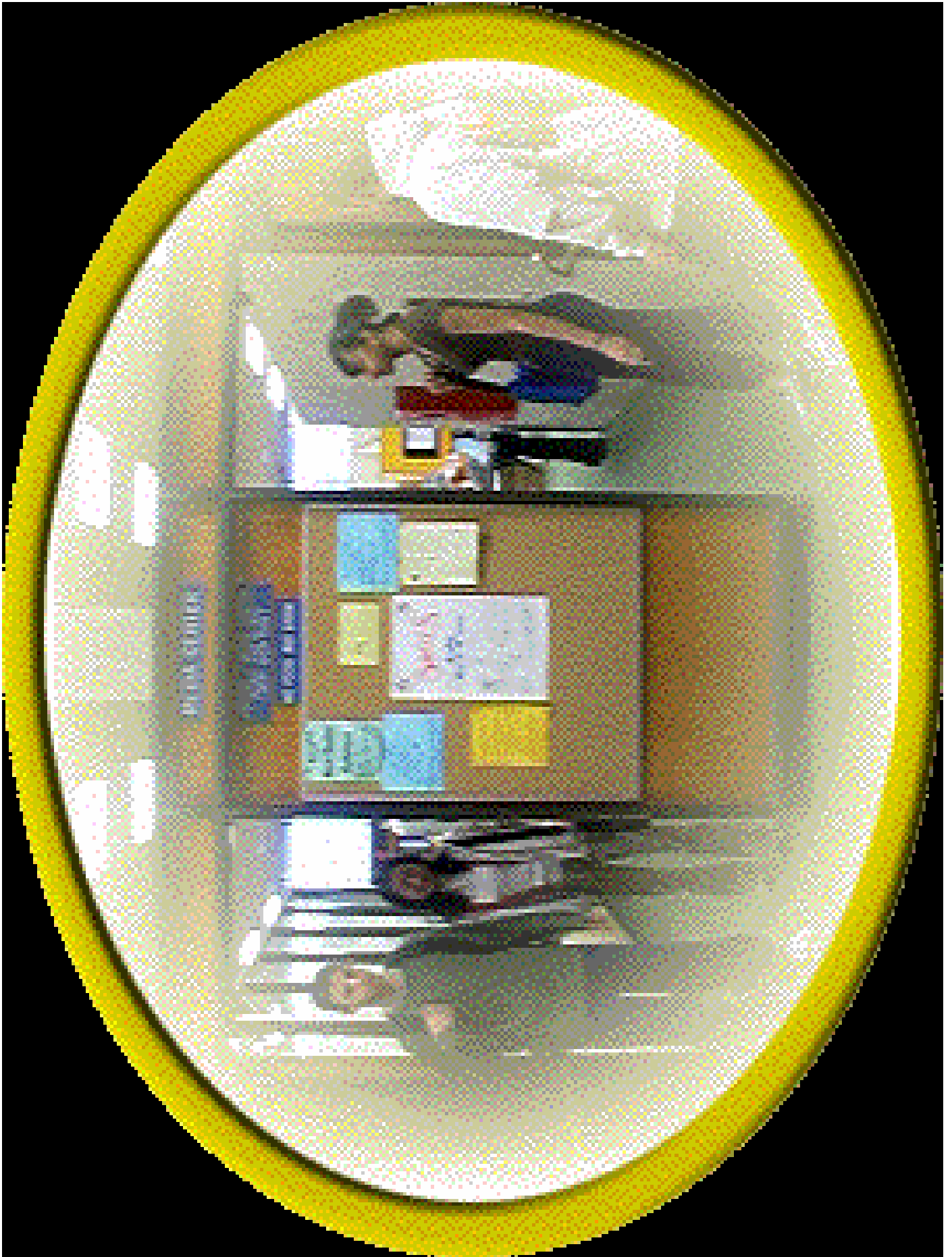
A Member of the Gunderson High School Foundation is any person who has made a \$25 or more cash contribution to the Foundation. The term of membership shall be the corporate fiscal year (July 1 to June 30) in which the contribution is made. Foundation members shall have the right to elect the Foundation's Board of Directors and shall have other rights per Corporate Laws of the State of California.



Gunderson Foundation Governance

The Gunderson High School Foundation shall be governed by a Board of Directors numbering no less than five nor more than thirteen elected to two year terms by the Foundation Members.

The Board of Directors shall elect an Executive Committee annually consisting of the Board President, Vice President, Secretary and Treasurer. The Principal of Gunderson High School shall co-chair the Board of Directors with the Foundation President.
